Even elder brother-in-law of Sanju (Toto driver) namely Sri Kanai who living in behind of the Matigara P.S continuously harassed and threatened to me and my sister Farida Begum by various way and

granddaughter under treatment and she admit in Medical Hospital. After physical examination Doctor admitted my granddaughter and on several medical tests the Doctor said us that thigh bone of left leg is broken and scalp of head also broken for the accident. Till now my Medical College & Hospital, Siliguri, Dist. Darjeeling on same day. senseless condition and they were shifting her at North Bengal

Thereafter, some local people rescued my granddaughter in escape from the place by leaving his vehicle at place of occurrence. places then the Toto driver Sri Sanju, S/o- Unknown somehow he house and she got several serious injury. When incidents was took namely Marzina Khatun @ Amina Khatun in front of our resident vehicle Toto without any number run and hit to my granddaughter would like to inform you that on 27/06/2025 at about 10.00 a.m. one of Matigara Bazar, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling, I, Sahira Bannu, W/o- Md. Sabaratu @ Md. Sabratu, Resident
