Jamuna Podder and her family possessed 7(seven) RKSY II Cards having Card Nos. 0800880228,1214073105.1214073108,2002241924,1214073109,1214073110 & 1214073107. She had applied earlier Online for conversion of the RKSY II cards to RKSY I cards for his family through Online Form 8, which was rejected by the Block Sub Inspector in charge after conducting physical Enquiry and finding the family ineligible for conversion.

However, Mohan Paul S/O Sasthi Paul resident of Paul Para (Hat Bhora Jote), P.O: -Rangapani, P.S: -Bagdogra, Dist:-Darjeeling contacted her and told her that he will be able to convert her DRC'S into RKSY I Category and for that he took Rs 2700 from her as per her view.

Mohan Paul had applied for self-service mode XIV for the DRC'S of Smt. Jamuna Podder and had merged the DRC'S with Sushila Barman 0600891135 RKSY I family. This is a serious offence committed by Mohan Paul; Hence, for which necessary legal action has to be taken against him for misleading the DRC Holder Smt. Jamuna Podder and also misusing of the Citizen's Home of the Government Website WB.FOOD.GOV.IN.
