I, Smt. Urmila Gupta Prasad, wife of Late Amit Kumar Gupta, R/o. Saheb Para, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, would like to state that today i.e. on 03.07.2025 (Thursday) at about 2.00 P.M. one of my relative namely Smt. Manki Devi, W/o. Late Ashok Gupta along with her two daughters namely Sashi Gupta @ Priti Gupta (Mobile No. 9883929663), Rinki Gupta, both daughters of Late Ashok Gupta, present address not known suddenly came to our house and started shouting, using bad & foul language and entered our house by breaking the locks with an intention to commit an offence. They were carrying small iron rods with them. Today they broke the locks of the house and forcefully entered my and started using slang language at me and attacked me with an intension to physically abuse me. Earlier also Sashi Gupta @ Priti Gupta had done such type of act. She came to my house on 16-05-2025 (Monday) i.e. and jumped through the front wall. Soon then I shouted and came out of my house and called my neighbours for help. I also called the Bagdogra Police and as soon as the Officer of Bagdogra Police Station came, Priti Gupta fled away by jumping from the back side of the house. On 16.05.2025, I went to Police station but the matter was resolved and I din't lodged the complaint against her but again today she came with her family and break the lock of my house and entered forcefully. They are very dangerous and can do anything.

Finding no other option, I came before you. If Priti Gupta & her family is not restricted then she might create a big problem in future & might again try to assault me and my minor son.

It is requested before you in folded hands to kindly take strict necessary action against Manki Gupta, Priti Gupta & Rinki Gupta so that they can be punished.
