Sir,

With due respect, I, Sri Subhrajyoti Paul, Son of Late Santi Ranjan Paul, Resident of F/2124, Uttarayan Township, P.O. & P.S. Matigara, Dist- Darjeeling, Pin - 734010, want to inform you that my elder brother namely Sri Sibajyoti Paul, Son of Late Santi Ranjan Paul is the registered owner of Maruti Suzuki Swift Dzire (PRME.SHERWOOD BROWN) having Registration No. WB-74-BJ-5042, having Chassis No. MBHCZFB3SNA193523 & Engine No. K12NP4055750. The said car is listed on Zoomcar App for rent.

On 23/06/2025 at about 11 a.m., one Golam Rabbani (Ph. 86702-33417) had booked my aforesaid vehicle through Zoomcar. One person namely Tapan Basu (Ph. 81010-68630) on behalf of Golam Rabbani had taken my vehicle from my home. Thereafter, the said person kept the said vehicle and the said rent was extended upto 02/07/2025. On and from 02/07/2025, the said rent in respect of the vehicle was neither extended nor the vehicle has been returned to my home. Later, when we called Golam Rabbani, he told us that he has booked the said vehicle and given the said vehicle to said Tapan Basu. On the very day, we have called Tapan Basu (Ph. 81010-68630) but his number came switched off. Later, we tracked the GPS location of the vehicle and found that the said vehicle is lying near Kakarvitta Eye Hospital, Kakarvitta, Nepal. Immediately, my elder brother have informed the said incident to Zoomcar but the said matter is still pending. We are totally scared that the said person might misappropriate our aforesaid vehicle due to which we might suffer irreparable loss.

Therefore you are requested to take proper legal action against the said persons and help me to recover my vehicle and oblige me.
