Sir,

In producing herewith following seized article i.e one full set of Hukkah seized under proper seizure list duly signed by the whiteness.

In this regard I, ASI Debasish Das, presently posted at Siliguri PS, SPC do hereby lodge written complaint against the owner of a café named and styled as 'Aura Infinity' situated at Shyam Plaza, S.F Road, Ward No-9, PS- Siliguri, Dist- Darjeeling and his associates to the effect that on 03.07.2025 at about 22:18 hrs received a specific source information that the owner of said café shop along with associates illegally provided Hukka to their designated customers by violating the official order. The matter has been diarized in GD vide Siliguri PS GDE No. 152 dated 03.07.2025. Accordingly, I informed the matter to the Inspector-in-Charge, Siliguri Police Station, SPC and expressed the entire information. Accordingly he directed to me to work out the information, immediately, at 22:25 hrs as per his kind direction myself along with ASI Subir Sen, ASI Rabin Lama, C/160 Soumen Sarkar all of Siliguri Police Station, Siliguri Police Commissionerate left for the said café shop situated at Shyam Plaza, S.F Road, Ward No-9, PS- Siliguri, Dist- Darjeeling to verify the veracity of the information which refers to Siliguri PS GDE No. 153 Dt. 03.07.2025 by Govt. Vehicle.

At about 22:40 hrs we reached there and found that the owner of the said café along with his staffs were busy to provided Hukka to their designated customers and while I asked him to produce the license for selling hukka, he failed to produce the same. On being interrogation, he stated that although he was aware about the guidelines of Govt for selling Hukka, he violated the Govt. order and run the business illegally without valid license for his wrongful gain since long. Accordingly, I seized one full set of Hukka under proper seizure list duly signed by the witnesses through audio-video method in between 22:25hrs to 23:20 hrs but during that time the owner escaped from the spot.

Therefore, I request you to start a specific case under proper section of law and take proper legal action against the owner and his associates of the café named and styled as 'Aura Infinity' situated at Shyam Plaza, S.F Road, Ward No-9, PS- Siliguri, Dist- Darjeeling run the café illegally by providing Hukka to their designated customers by violating the official order.
