Subject - First Information Report
Respected Sir,

This is to bring to your notice that I, Arman Dugar, S/O Sumam Kumar Dugar, resident of Gangamagar Road No. 2, Ward No. 5, Teacher's colony, want to raise a complaint against theft at my residence. Due to work, I travel to Purnea, on 01.07.25, I had carefully locked my house and traveled to Purnea, Bihar via 6:40 am bus. Today morning (04.07.25), my father received a call from our neighbour mentioning that the doors are open and there are no locks. Out of suspicion my father asked the neighbour to check the house where it was found that the locks of both the front main doors were open and on entering the house (through the door broken by thieves) it was found that the thieves have broken the almirah lockers and have stolen jewellery and cash.
