common friend had approached me with urgent request
to use my vehicle being no WB 74 BG 0414 on

return my vehicle after 10 days.

In good faith I handed over the same.
After the days later when I asked him to give me the vehicle, he started making excuses and threatened to kill me he also demanded a sum of Rs 5,00,000 (Five lakhs only) when I investigated further I found that ~~I had cheated~~ and Mr. Somnath Kerkhadije not only cheated me but some other persons also.
Mr. Somnath Kerkhadije willfully breached the trust of us and instead of returning the vehicle he along with his wife fraudulently mortgaged or sale our vehicle to the third party in different places without any authority, consent or knowledge of us.

Therefore, I request you to kindly into this matter and take major action as per law.
