I, Sahida Khatun Wife of Md. Kalam resident of Ratan Lal Busty, Ward No.01, P.O. & P.S. Pradhannagar, Siliguri-734003, would like to inform you that my daughter Ruksana Khatun (Mehar) went to her school Bharati Hindi Vidyalaya (H.S.) as usual yesterday i.e. on 02/07/2025 in school uniform with her school bag at scheduled school time. But she did not come back to home in time, then I with my husband and son Tamanne Ali started enquiring and searching her from 5 P.M. We also informed her school teacher about her said fact about my daughter and surprisingly he informed that my daughter was absent on that day which made us more curious and afraid.

Sir, my said daughter is about 18 years and 30 days old , her date of birth is 03/06/2007. Copy of her aadhar card and admit card is enclosed herewith. Her height is about 5 ft and she is fair and slim in look. Her photo is also enclosed herewith for her identification.

Later, I came to know from few students of the school who asked me not to reveal their name and informed that Raunak Prasad S/o Satya Prasad, having Mobile No. 9144563408, resident of Gas Godown Road, Prasad Hotel , Ujjanu, P.O. & P.S. Pradhannagar, Siliguri might have kidnapped my daughter and taken her away forcibly to some other unknown place. Sir strongly apprehend that my daughters life is in danger and she might also be sexually tortured and assaulted because I have come to know that the said boy Raunak Prasad is of pshyco nature and cruel also engaged with many antisocial activities. His family members including his mother and sister are threatening us over telephone several times and they might also be part of this kidnapping.

I therefore request you to immediately register my complained and take necessary action against the said Raunak Prasad and his family members so that my poor daughter be traced and found as early as possible without any harm.
