Sub: - Prayer for lodging a specific case under proper section of law.

Sir.

In producing herewith 01 (One) arrested accused person namely Dhananjoy Roy (35 yrs S/O Pradhan Roy of vill Monyagachh, PS Bhorer Alo, Dist Jalpaiguri along with seized vehicle (Tractor) bearing registration no WB-73F-7124 with trolley loaded with river bed materials (Sand).

 ASI Sk Tinku of Bhorer Alo PS/SPC do hereby lodge this written complaint against the above noted accused person to the effect that on 04.07.2025 at 08:05 Hrs I received a secret information that a tractor bearing registration no. WB-73F-7124 was illegally carrying material from the river bed towards Monyagachh village under Bhorer Alo PS. Accordingly I informed the matter to O/C, Bhorer Alo PS and as per order myself along with force went to work out the information vide M.C.C No. 611 Dtd. 04.07.2025. At about 08:45 hrs myself along with force reached Monuagachh village under Bhorer Alo PS and detained a vehicle (tractor) bearing Registration No. WB-73F-7124 loaded with river bed materials (sand), which was proceeding inside Monuagachh village. The driver was trying to flee by abandoning the vehicle on the spot. However, I apprehend him and asked for valid papers for carrying the river bed material in the vehicle, but he was unable to produce the valid papers in regard to carrying the sand in the vehicle.

As such there was a sufficient reason to believe that the above noted accused driver is engaged in illegal mining of river sand for transporting the same without legal royalty/ papers as per rule, for selling clandestinely for their wrongful gain. Accordingly, after reporting the matter to the O/C, Bhorer Alo PS I, seized the said sand laden vehicle bearing registration number WB-73F-7124 under proper scizure list. The scizure was made in between 09:05 Hrs to 09:15 Hrs on 04.07.2025 under videography and arrested the accused driver Dhananjoy Roy (35 yrs) S/O Pradhan Roy of vill Monyagachh, PS Bhorer Alo, Dist Jalpaiguri after appraising him the ground of arrest.

I therefore pray before your kind self that a specific case under appropriate section of law may kindly be initiated against the arrested accused Dhananjoy Roy (35 yrs) S/O Pradhan Roy of vill Monyagachh, PS Bhorer Alo, Dist Jalpaiguri and arrange for its investigation.
