committing the offence of Forgery, Cheating, Criminal
Breach of Trust with Common Intention.

Respected Sir,

With due respect, I, **SMT. MALATI KARMAKAR**, Wife of Sri Amulya Karmakar, Resident of Hakim Para, Siliguri, P.S. Siliguri, Dist. Darjeeling and also resident of ^{Haider Para, New Palpara - Now Sree Ma Sarani Bye Lane.} East Vivekananda Pally, Sukanta Nagar, Ward No. 38 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint to the effect that I am the absolute and exclusive owner of land measuring $1\frac{1}{2}$ Kathas or 0.025 Acre, together with house structure standing thereon, appertaining to and forming part of Plot No. 310, recorded in Khatian No. 480, of Mouza - Dabgram, J.L. No. 2, Sheet No. 12, Pargana - Baikunthpur, situates within Ward No. 38 of S.M.C., under the Police Station - Bhaktinagar, Dist. Jalpaiguri and I have acquired the same by virtue of a Deed of Sale, executed by Sri Kartick Sarkar, Son of Late Gopal Sarkar of Dabgram, Haider Para, Dist. Jalpaiguri, on 14/07/1988 and the same was registered in the Office of the A.D.S.R., Jalpaiguri being Document No. I - 4513 for the year of 1988 and since then, I have been possessing, enjoying and occupying the said property in my actual khas and physical possession, having right, title and interest therein, free from all encumbrances and charges whatsoever.

Sir, in course of enjoyment of the said property, I have also mutated my name in the Office of the B.L. & L.R.O., Rajganj and a separate Khatian has been opened in my name vide L.R. Khatian No. 14 and the plot has been identified as L.R. Plot No. 18 and since then, I have been paying the Land Revenue and other Taxes to the authorities time to time.

Sir, thereafter I have also mutated my name in the Office of the Siliguri Municipal Corporation for Holding Mutation with respect to my aforesaid property and accordingly, the concerned authority has issued a Holding Certificate to and in my name vide Holding No. 707/977 of Ward No. 38 of Siliguri Municipal Corporation and I have been paying the taxes to the concerned authority time to time. Moreover, after obtaining the Holding Mutation in my name, I have also obtained the electric connection from the authority of the WBSEDCL vide Consumer ID: 412240069.

Sir, in order to look after my aforesaid property, I have appointed one of my distance relative namely **SRI SOUMITRA KARMAKAR**, Son of

Malati Karmakar

Late Sunil Karmakar, to stay therein for temporary basis and since last few months, I have asked and requested my said distance relative namely Soumitra Karmakar to vacate and handover the khas and physical possession of my aforesaid property in my favour but he delayed the matter on different pretext and recently, I came to learn that said Soumitra Karmakar by producing some forged and fabricated documents before the authority of Siliguri Municipal Corporation, has obtained a Holding Mutation Certificate with respect to my aforesaid property in his name vide Holding No. 202/1/N of Ward No. 38 of Siliguri Municipal Corporation and one Enlistment Certificate in respect of the shop namely "Karmakar Store" knowingly well that he has no right, title and interest in and over my aforesaid property and after obtaining the said Holding Mutation in his name, said Soumitra Karmakar also obtained a separate Electric Connection in his name by using those forged and fabricated documents as genuine and in these way, not only he deceived and cheated me, he also deceived the authority of Siliguri Municipal Corporation as well as the Department of WBSEDCL by using those forged documents.

Sir, I have already intimated the aforesaid facts to the Commissioner of Siliguri Municipal Corporation as well as the Station Manager of Hakimpara CCC, WBSEDCL, in writing for such mal-practice of said Soumitra Karmakar

I, therefore, request you to kindly investigate into the matter and please take appropriate legal steps against said Soumitra Karmakar and others as per the provision of law and obliged thereby.
