With the subject mentioned above, I would like to inform you that there has been a theft electrical wires Sir, from the electrical wiring of the Nepali medium of our school on the night of 04.07.2025 by unknown person(s) also the electrical fans were vandalized. In this connection, it is also to inform you that same thing happened to the Bengali medium few days ago to all of the classes on the first floor. All the electrical wires from the electrical wiring were stolen and fans in the classroom were destroyed incurring huge loss to the school. The theft in the Bengali medium was reported verbally to police no action was taken.

In this connection, it also to inform you most importantly that they have also targeted the school's office and staff rooms causing some damage. The wires from the girl's bathroom adjoining the office were also stolen. This is a government school, catering the need of education to the lower and poor sections of the society in this area. It is the only High School located in the entire Salugara area stretching to Sevoke.

Furthermore, this is loss of government property which is causing a great difficulty in running regular classes in the school, as it is very difficult to sit in the class without fan in these hot days of summer. We have undertaken the repair work of wiring and fans of some classes of the school from our school's fund but will not be able to fully complete the repair works due to shortage of fund.

This theft has become a regular phenomenon causing huge loss to the school which we are not able to bear as per our present financial condition of the school. In our view there must be an involvement of some local person(s) in this regular theft and vandalizing. School does not have any nightguard which making much more difficult to stop the theft.

Therefore, I request you to conduct a thorough investigation regarding the matter and find the culprit(s) and book them according to the law.

I, earnestly request you to take necessary action immediately as school is facing tremendous monetary loss and burden which is making difficulty in running the school smoothly.

We are expecting your co-operation regarding the matter and to take necessary action at the earliest.
