I would like to inform you that since 15 years of my marriage I have been mentally and physically tortured by 1) Sk. Samjad Ali s/o Sk. Sikander Ali mob. 8001187986, 2) Sk. Sikander Ali s/o late Helaluddin, 3) Aliya Begum w/o Sk. Sikander Ali resident of Rukundipur, near Kabristan ratha, 732205, 4) Sanjana Bano w/o Tanvir Shah Nawaz, 5) Tanvir Shah Nawaz s/o Shah Nawaz Hossain mob. 9832528899 resident of Maheshmati, Daha more, P.O. PS English Bazar, Malda-732101. 6) Habibullah Sheikh s/o late Sikander Ali mob - 9434070251, resident of c/o Akbar Ali 1st floor, Kamrangaguri, near Satellite tower, Siliguri.

My Father Habibullah Sheikh forcefully made me marry with divorcee person (which I came to know after my marriage) namely Sk. Samjad Ali 16th July 2010 by giving my in-laws hefty dowry money and gold ornaments to clear his way to marry with my step-mom whom he was having an extra-marital affair as my mother died on 23 October 2009. Since the day I got married my husband and my in-laws as mention above started torturing me with abusive and filthy language

and almost everyday they use to fight with me for more dowry by saying that my father had promised them to give more cash after 2 years of my marriage for my husband well being and further education. My In-laws are having more than crores worth property and cash as well but their greedy nature made my life hell. Because of my father breach of trust with my in-laws they use to hit-me, torture me all the time. By the time passed and situation got more worst so I joined St. Joseph's School bhaktinagar as a teacher job for my mental peace but because of my husband cruelty nature he forced me to leave the job and not let me go to school after every alternative days then I had to quit the job because they had threatened me to kill me through slow poison. Then I started doing restaurant business and other business to keep myself independent and emotionally stable and to come out from depression but my husband and in-laws are always against me and forcefully stopped me doing business too. I came to know that my husband and in-laws use to torture his ex-wife and because of his drinking nature
