

Sub: Complaint against i) **Smt Babli Ganguly**, Wife of Sri Pritam Ganguly, Daughter of Late Naresh Chandra Dey @ Naresh Dey, ii) **Sri Pritam Ganguly**, son of Nripendra Chandra Ganguly, both are residents of Pratima Bandhopadhyia Sarani, Deshbandhupara, P.O. Siliguri Town, P.S. Siliguri, Dist- Darjeeling, Pin code- 734004.

Sir,

I, **SMT LAXMIRANI DEY @ LAXMI DEY**, Wife of Late Naresh Chandra Dey @ Naresh Dey, Resident of Banaful Sarani, Nabagram, Ward no. 33 of Siliguri Municipal Corporation, P.O. Bhaktinagar, P.S. N.J.P., Dist- Jalpaiguri, Pin- 734007, beg to inform you the following facts:-

1. That I am an old aged widow woman and my husband died on 17.04.1998 and I have three children i.e., two sons namely Sri Narayan Chandra Dey and Sri Debabrata Dey, one daughter namely Babli Ganguly.
2. That in the year 2010, the above named alleged persons i.e., my daughter and son-in-law got married and after their marriage they have started residing at my house at Banaful Sarani, Nabagram, Ward no. 33 of Siliguri Municipal Corporation, P.O. Bhaktinagar, P.S. N.J.P., Dist- Jalpaiguri, Pin- 734007, and I gave all the expenses to them for maintaining their livelihood. In the year 2021, my daughter gave birth of a male child and at that time all the medical expenses were borne by me.
3. That from the year 2023, the alleged person nos. 1 & 2 i.e., my daughter and son-in-law both started pressurizing upon me to give my property in the name of my daughter and started to abuse me both physically and mentally and were/are using filthy languages towards me. Day by day the level of torture has been

increasing towards me by my daughter and son-in-law. They used to quarrel with me without any reason. And finally my daughter conspired with her husband and tactfully made a gift deed and took my signatures therein and registered the said gift deed in the name of my daughter vide Deed No. 1555 for the year 2024, registered at the Office of A.D.S.R. Bhaktinagar for the land measuring 2 kathas alongwith my residential house (tin shed pucca structure). At the time of registration, I could not protest against my daughter as my daughter used to blackmailing me by saying that she will commit suicide if I do not give the property in her name. My daughter and son-in-law compelled me to execute the said deed in the name of my daughter under coercion and force.

4. That day after of the registration, my daughter went to her matrimonial house alongwith her husband and son and since then my daughter was/is trying to occupy the property and trying to evict me there from. I am very helpless lady in the present situation as my daughter always used to give threatening me that she will evict me from my residential house. In that house now I am living with my elder son who is unmarried and he use to take care of me. After registration of the property, my daughter never looks after me and never gives me a single penny for my maintenance. Whenever I called her over phone for my necessity then she use to filthy languages to me and insult me.
5. That on 28.02.2025 at about night 8.30 p.m., my daughter called me and started to pressurize me to leave my house and threatening me with dire consequences. Thereafter continuously my daughter pressurizing upon me to leave my house.
6. That thereafter on 20.03.2025 at about noon 3.00 p.m. my daughter entered into my house along with 3 miscreants and stated that she will take loan by giving mortgage of my house or she will sell my house to any third person. Thereafter my daughter again gave pressure upon me to leave my house.
7. That present days my daughter continuously pressurizing upon me to leave my house and create quarrelsome circumstances in my house and threatening me with dire consequences. I am an old aged widow woman and very helpless in the present situation. I am also arthritis, high blood sugar patient and I cannot bear the tortures inflicted by my daughter
