Sir,

In producing herewith three (03) accused persons namely 1) Kripa Roy (27) s/o Dilip Roy of Ranjapani, Kodali para PS Phansidewa Dist Darjeeling A/P Kawakhal Bidhanpally PS Matigara Dist Darjeeling 2) Manoj Das (26) s/o Lt Shankar Das c Radhabari near BSF Camp PS New Jalpaiguri Dist Jalpaiguri 3) Shiv Chaudhury (20) s/o Subal Choudhury of Maharaja Colony beside Bishal Mega mart PS Siliguri Dist Darjeeling along with seized articles viz:-

1. One iron made Hasua length approx 30 inch fitted with wooden handle.
2. One baseball bat approx length 32 inch
3. One iron made hummer approx length 12 inch.
4. One red colour electric torch light
5. One big size Nylon bag ,green and white colour.

I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 10/12 persons to the effect that on the night 04-07-2025 at 00-05 hrs received secret source of information to the effect that some miscreants with deadly weapons assembled in a dark place at Kashmir colony school ground under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 175 dt. 04.07.25 . As per your kind direction at 00-15 hrs myself along with, ASI Manoj Mjumdar C/1462 Sajan Tamang, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS vide NJP PS GDE No. 176 dt. 04.07.25 for Kashmir colony school ground to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 00-45 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the ground of Kashmir Colony, found a group of 10/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted three (03) persons and the others 08/09 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Kashmir colony under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not find any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graphy as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS. The seizure was made between 01-35 hrs to 01-55 hrs and the all persons were arrested with proper memo of arrest.
