During my stay at my elder sister's house, my husband called me and asked me to return back to the house and also promised me that he will not commit further torture upon me and believing his version to be true, I accompanied my son return back to the house and immediately after reaching there, my husband asked me that "What amount I have earned yesterday" in a bad and derogatory manner and also told me that he will check my private parts before allowing me to stay in the house as to whether I have committed any wrong or not and also started to cause mental torture upon me and also threatened me with dire consequences and finally I was compelled to again return back and took shelter at my elder sister's place. Now, my husband has started sending some voice messages in WhatsApp stating inter alia that If I do not return back to the house or to live with him, he will commit suicide and put me behind the Iron Bar.

Madam, after I started to reside at my elder sister's place, I have been receiving constant threats from my husband and for that reason I have been passing my days in extreme fear and anxiety.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against my husband, under the relevant sections of law after treating my written complaint as an FIR and obliged thereby.
