I Smt. Subarna Das, daughter of Ripon Das, Wife of Ramesh Mandal, resident of Devidanga, P.O. – Champasari, P.S – Pradhan Nagar, Siliguri, District – Darjeeling, Pin – 734003.

I beg to inform you that I got married as per Hindu rites and customs on 02.03.2017 with one Ramesh Mandal at Devidanga near Champasari Gram Panchyat Office and right after marriage I was subject to mental and physical tourcher and was threatened of doing some black magic for which me my family members would become mad and kill ourselves.

That as the days passed the level of torture increased by Ramesh Mandal and he also use to take me to various black magic place to different tantrik and Ojha's as I was not able to conceive a baby and after the intervention of the family members we were advised to take advise from medical practitioner and after several test and examination it was found that Ramesh Mandal is not capable enough to help me to conceive a baby and for this reason Ramesh Mandal started torturing me more and more day by day. And many a times have threatened to kill me.

That since it was not possible for us to live as a husband and wife hence I sent the said Ramesh Mandal a legal notice for Divorce and later he agreed to file a Divorce case mutually and accordingly a mutual divorce suit has been filed being Mat. Suit No. 156 of 2024 Dt. 06/12/2025 and a date was fixed for Reconciliation and Hearing on 06/06/2025 but intentionally the said Ramesh Mandal did not turned up in the Court and a next date was given by the Ld. Court.

That today when I was returning home from my work place from North Bengal Medica at about 07:30 to 08:00 pm the said Ramesh Mandal suddenly came from back side hold my hand and dragged me saying that I will take you to my home and kill you and when I rescued my hand from him then he hold my hair and dragged me on the streets near Netaji Sporting Club lane and also snatched my mobile phone and took with him but later he called my brother

and handed over the mobile phone to my brother and has also threatened my brother with dire consequences and was asking about my whereabouts as I stay in a rented premises at Pradhan Nagar.

Therefore I request you to kindly look into the matter and help me and my family to stay peacefully and help me from the illegal clutches activities of the said Ramesh Mandal as I have nowhere else to go hence I have come before your Good Office for help.
