Respected Sir

This is to inform you about theft in our house on 2 July 2025 night, Sir, we learnt about the incident only the next day when our tiles mistry informed us that his marble cutting machine was missing from the ground floor where renovation work was going on. We then discovered the following from CCTV footage.

The intruder/Thief approached our house in his scooter on 2 July night around 20.47hrs and parked his scooter near the electric pole outside our main gate. At about 20.48hrs. He made entry into our house (1st floor) with a sharp instrument in his hand. He left the room with a briefcase at about 20.53 hrs. The Thief then left our premise in his scooter after about 4-5 minutes, around 20.56hrs the scooter came back. This time the thief entered the ground floor and left after 5 minutes with a bag in his hand. The briefcase removed from the 1st floor contained apparently documents and the bag removed from the ground floor contained one marble cutting machine and one rod cutting machine.

Sir, we informed the police officials from Bhaktinagar PS the following day 3 July about the incident and even shared with them the CCTV footage to trace out the culprits. We tried to obtain CCTV footage on 04 July and 5 July from other cameras in the vicinity but it was not possible to get the scooter number and hence the delay in lodging this FIR.

Sir, in view of the above stated facts, the locals especially the women folk are scared and concerned. Hence you are requested to look into the matter. Investigate and catch the culprits and take stern action at the earliest. For your guidance, we attach herewith colour photograph of the thief/culprit as captured by CC camera (refer to page 2)
