Respected Sir/Madam,

Myself Soupar Basak, S/o - Basudeb Basak currently residing at the house of Mr. Hriday Biswas, vill - Selterbari, P.O. - Balaram, P.S. - Bhorer Alo, Dist - Jalpaiguri, Pin - 735135 and permanent resident at c/o - Basudeb Basak, vill - Hatsimla, P.O. - Samudraganh, P.S. - Nadanghat, Dist - Purnea Bardhaman, Pin - 713519. I would like to report a serious incident that occurred near Gonden More.

On 5th July, 2025 around 09:50 PM, I was commuting to office by bicycle and I was unexpectedly approached by approx. nine to ten individuals who were on motorcycles. I noticed them before in front of Sakambari Atta mill which is beside my house. After coming out from home, they started following me in the midway, they stopped me and proceeded to physically assault me.

On asking, they issued a direct threat, specially instructing me not to report to office anymore from that point onwards, also mentioned that something wrong happened in office because of me.

During this assault, they hit me on my face, and head. They pulled out my eyeglasses and broke it and also threw my bicycle on the roadside jungle.
