Sir,

In producing herewith three (03) lady accused namely (1) Chaina Das (F/33 years), W/O- Dipankar Das of Patiram Nicha Bandar near Patiram Boys' High School, PO+PS-Patiram, Dist- Dakshin Dinajpur, [2] Kanika Haldar (F/35 Years), W/O- Bhakta Haldar and [3] Bharati Haldar (F/50 Years), W/O- Lt. Kanak Haldar both are of Beltapara near Beltapara Primary School, PO- Pokhiaga, PS- Mathabhanga, Dist- Cooch Behar, presently at Krishnanagar Colony, Paglabusty, PO- Sahudangihat, PS- Bhorer Alo, Dist- Jalpaiguri [All the addresses could not be verified] under arrest along with following seized articles:

[i] One Yellow colour printed plastic sack styles as "SAKET sikha premium quality masoor Dal" containing weight 12.110 Kgs (approx.) of said to be ganja concealed inside pink colour plastic printed packaging pouch styled as "Lucky charms" marked as Exhibit-A.

[ii] One Green colour printed plastic sack styles as 'RANI SORTEX CLEAN CHANA DAL' containing said to be Ganja weighing 12.740 Kgs (approx.) concealed inside pink colour

plastic printed packaging pouch styled as "Lucky charms" marked as Exhibit-B.

[iii] One White colour printed plastic sack styles as 'SAF SARTAJ RICE' containing said to be Ganja weighing 11.485 Kgs (approx.) concealed inside pink colour plastic printed packaging pouch styled as "Lucky charms" marked as Exhibit-C.

[iv] One Red colour Realme C12 Mobile phone having IMEI1-866413055062911/13 & IMEI2-

89918400500020156172 containing SIM1- 9679947061 marked as Exhibit-D.

I, SI Sailesh Subba of Bhorer Alo PS, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted three arrested accused ladies namely Chaina Das, Kanika Haldar and Bharati Haldar who had been arrested for contravening the norms of NDPS Act to the effect that today on 08.07.2025 at 08.45 hrs myself received a secret source information that three ladies possesses huge quantity of Ganja at Krishnagar Colony under PS- Bhorer Alo with a view to sale the same in the adjacent areas and they could be caught red handed, if approached immediately. Wasting no time I diarised the information to Bhorer Alo PS General Diary Book vide GDE NO- 261 Dated 08.07.2025 and consequently informed of the tip off to you in written for kind instruction. Subsequently, being directed, myself along with ASI- Rana Jadav, NVF/159 Debranjan Sarkar, LC/1314 Moumala Roy, LC/1376 Leela Roy, LCV/325 Sabita Roy, LCV/332 Mina Sarkar along with investigation kits left PS at 08.55 hrs for perusing the information by Govt. Vehicle. This refers to Bhorer Alo PS GDE No- 262 Dated 08.07.2025.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

While going to Krishnanagar Colony we stopped and contacted two persons namely i) Sonu Jha (22), S/O- Bhola Jha and ii) Hira Nath (18), S/O- Binoy Nath both of Krishnanagar Colony, Sahudangihat, PS- Bhorer Alo, Dist- Jalpaiguri and make them aware of the information in hand in written and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached at Krishnanagar Colony at 09.35 hrs.

On reaching there, I contacted with my source and subsequently being pointed by my source,

cordoned off three ladies at Krishnanagar Colony.

Thereafter we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. As the odour of ganja was coming out of the sacks of their possession there was enough reason to believe that the article inside the sacks were ganja.
