 - 1. That I am the legal married wife of Shekher Thakur, S/o Sri Umesh Thakur of Gulma T.E, under Pradhannagar P.S, Dist Darjeeling.
 - 2. That on 03/07/2025, at about 12.30 PM to 1.00 PM, my husband and in-laws namely Umesh Thakur (father-in-law), Smt Gita Devi Thakur, Abhisek Thakur (brother-in-law) and Smt Pinky Thakur, W/o Raj Kishore Thakur, all together brutally assaulted me without any provocation. During this incident, they attacked me with iron rod with the intention to kill me?
 - 3. That on the same day at around 11PM my husband also tried to kill me by pressing pillow over my face.
 - 4. That as a result of the assault, I sustained serious injuries and I informed to my mama on 03.07.2025at around 8 PM and they came on 04.07.2025and immediately admitted to Nivedita Nursing Home, Siliguri. I have been under medical treatment for the injuries and trauma suffered and have been discharged today (08/07/2025).
 - 5. Further, I state that I have been subjected to continuous physical and mental torture on a daily basis since my marriage and they never allowed using mobile phone, they always keep me in key and lock. They regularly harassed me demanding dowry in the form of cash and valuable items from my parental house.

I therefore request you to kindly register an FIR against the above-named accused persons under appropriate sections of the BNS, including but not limited to:

Kindly take immediate necessary legal action against them and ensure my safety.

I am ready to cooperate fully with the investigation and provide medical reports, witness details, and any further evidence required.
