With due respect, I SI Pratap Basak s/o Late Baneswar basak of Ashighar Out Post under Bhaktinagar P.S, SPC do hereby lodge this written complaint against the road blockade at Baneswar More E.M By-pass road.

The facts of the case in brief are that on 08.07.2025 at morning in course of mobile duty under Ashighar Out Post PS, Bhaktinagar area at around 08.15 hrs received an information that members and supporters of BJP Dabgram/Fulbari Mandal Committee under the leadership of Sri Amrit Poddar, President of Dabgram/Fulbari 4 No Mandal and Sri Kalidas Roy along with approx. 40/50 others leaders and members had blocked the West Bengal State Highway road at Baneswar More E.M By-pass road under Ashighar OP, PS Bhaktinagar without any prior information and permission from the concerned authority in the protest against incident which had occurred on 08.07.25 in midnight at South Ektiasal near Bazar in three Hindu mandir. After receiving the said information as well as instruction by OC Ashighar OP, I along with available officer and force immediately rushed at Baneswar More E.M By-pass road under Ashighar OP, PS Bhaktinagar and found that the above named persons with their leader and supporters approx. 40/50 had gathered and blocked the E.M By-pass road at Baneswar More, West Bengal State Highway illegally. Accordingly, I asked them that they cannot continue such road blocked without permission prior information. On hearing this they still & continue their road blockade. Due to this road blockade the vehicular movement towards Ashighar side and opposite direction towards Bhaktinagar side has been fully disrupted for around 30 minute. After the intervention of police team including superior officer they withdrew their road blocked.

Under the above facts and circumstances, I pray before your kind honor that a specific case against the abovementioned Sri Amrit Poddar, President and Sri Kalidas Roy along with approx. 40/50 others leaders and members of Dabgram/Fulbari 4 No Mandal under proper section of law and request to arrange its investigation.
