Dear Sir.

This is to inform you about a theft incident that took place today—Tuesday, 8th July 2025 between 9.00 am and 11.00 am at Don Bosco Staff Quarters, Opp. Auxilium Preparatory

As per the statement of our staffs residing there, namely, Mr. Rakesh Rai, Mr. Kiran Chettri. Abinash Xalxo & Mr. Siman Bakla, they had locked and left the quarters to work at Don Bosco School at around 9.00 am. At 11.00 am, when 3 of our staffs came back to the quarters for break, they were shocked to see that their house/quarter room had been robbed, wherein, all the 3 rooms main door locks were broken, and water taps in the toilets were cut and stolen. Even the electrical wiring wires were cut and stolen from the main switch board on the verandah. After entering and examining the rooms, it was found that money (around Rs. 11,000) was missing, 2 batteries (small) along with an old Samsung Mobile phone (wrapped with rubber band) was stolen. The almirah/shelf was opened and clothes were all scattered around the room. This whole incident took place between 9 and 11 am.

Sir, we are deeply concerned about the safely of our staff in and around the neighbourhood, as matters of thefts are increasing day by day.

We therefore, urge and request you to look into the matters seriously and take strict actions against the culprits in order to prevent theft incidents in the future and also to recover the stolen materials as mentioned above.
