Sir,

This is to bring to your kind notice that I along with my brothers are the owners-in possession of the below Scheduled land, measuring about 7½ Kathas or 0.13 Acres of land in Mouza Dabgram, P.S. Bhaktinagar (New), Rajganj (Old), which has been described more fully in the Schedule below, by virtue of a registered Deed of Gift. And we are in possession of aforesaid land since long.

One Dipak Kumar Singha, s/o of Late Bijoy Kumar Singha, Hemanta Kumar Singha, s/o of Late Bijoy Kumar Singha, Smt. Nitu Singha, w/o Late Jyotish Kumar Singha, Sri Nitesh Singha, s/o Late Jyotish Kumar Singha, Ms. Pratistha Singha, minor daughter of Late Jyotish Kumar Singha, Sri Sudarshan Singha, s/o Late Sudhir Kumar Singha, all residents of East Vivekanandapally, Nazrul Sarani, P.O. Rabindra Sarani, P.S. Bhaktinagar, District Jalpaiguri, PIN 734 006, along with two others, had tried to forcibly encroach on our aforesaid land, in the month of November, 2018, and I along with my brothers were compelled to file a suit being T.S. no. 389 of 2018, in the Court of the Ld. Civil Judge, Junior Division, Jalpaiguri, against the aforesaid persons along with an injunction application for restraining them.

On 31st August, 2024, the Ld. Civil Judge, Junior Division, Jalpaiguri, was pleased to pass the following order; "The ad interim order restraining the defendants and their men and agents from entering into the suit property and disturbing the Plaintiffs peaceful possession stands as it is till disposal of the suit".

It is pertinent to mention here that, I along with my brothers decided to construct a boundary wall around the said land for the purpose of protecting our lawful possession of the said land, and with this aim in view, we engaged a contractor (Thikadar). The local police station had also been informed regarding the said construction on 17th June, 2025, vide G.D.E. No. 652, dated 19.06.2025.

On 06.07.2025 at around 1:15 p.m., One Dipak Kumar Singha along with Hemanta Kumar Singha, in gross violation of the injunction order forcibly entered the suit land and partly damaged the plinth wall which was being constructed by me and further threatened me with dire consequences.

Under the circumstances I earnestly request you to take necessary action as per law against the aforesaid persons and also extend necessary cooperation in maintaining law and order, should any obstruction be made during the course of construction, by the aforesaid persons.

SCHEDULE OF THE LAND

All that piece and parcel of land measuring 7½ (seven and half) Kathas or 0.13 acres, in part of Plot no. 353 (Old), New (L.R.) Plot No. 40, appertaining to Old Khatian Nos.338 and 380, corresponding to New Khatian Nos. 3, 4, 6 and 7, Mouza Dabgram, J.L. No. 2 and 3(old), 2 (New), Pargana Baikunthapur, P.S. Bhaktinagar (New) Rajganj (Old), District Jalpaiguri, and within Ward No.38 of the Siliguri Municipal Corporation.

On the North: By the house of Rabi Dutta, sold land formerly of Uday Mazumder and now Anuj Jaiswal;
