Sir

In producing herewith following four arrested accused persons namely (1) Md Parbhej Alam @ Chotku-24yrs s/o Lt Abdul Rajjak of Gandhinagar near Milton school, ward no-43, PS Bhaktinagar, Dist Jalpaiguri (2) Md Tarvej Alam @ Barku-24yrs Lt Abdul Rajjak of Gandhinagar near Milton school, ward no-43, PS Bhaktinagar, Dist Jalpaiguri and (3) Prem Ray-30yrs s/o Lt Ramesh Ray of Jyotinagar near Gas Godown, PS Bhaktinagar Dist Jalpaiguri (4) Firoj Hussain-26yrs s/o Kamrul Hussain of Maharaj colony, near sony Mandir ward no-4, PS Siliguri Dist Darjeeling along with following seized articles viz:

- 1) One sharp cutting knife with plastic butt measuring approx 13 inches recovered from the exclusive and Conscious possession of Prem Ray.
- 2) One iron rod measuring approx 14 feet recovered from the exclusive and Conscious possession of Md Parbhej Alam @ Chotku. .
- 3) One screw driver measuring approx 9 inch recovered from the exclusive and Conscious possession Md Tarvej Alam @ Barku.
- 4) One iron rod measuring approx 14 feet recovered from the exclusive and Conscious possession of Firoj Hussain.

I, ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 09.07.2025 at 00:05 hrs received a specific source information that 7/8 miscreants have assembled at Eastern bypass road, near Himalaya Kanya Abasan under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No 506 dated 09.07.2025 and as per order I along with SI Srimanta Chatterjee, SI Youel Lepcha, ASI Khagen Barman, ASI Amardeep Chhetri with force (K-37 PS Mobile ) and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Eastern bypass road, near Himalaya Kanya Abasan under Bhaktinagar PS to work out the information in hand vide GDE No-507 dated 09.07.25.

At about 00.25 hrs we arrived at the at Eastern bypass road, near Himalaya Kanya Abasan as indicated by the source we noticed that 7/8 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 3/4 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they



were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 09.07.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Md Parbhej Alam @ Chotku -24yrs s/o Lt Abdul Rajjak of Gandhinagar near Milton school, ward no-43, PS Bhaktinagar, Dist Jalpaiguri (2) Md Tarvej Alam @ Barku-24yrs Lt Abdul Rajjak of Gandhinagar near Milton school, ward no-43, PS Bhaktinagar, Dist Jalpaiguri and (3) Prem Ray-30yrs s/o Lt Ramesh Ray of Jyotinagar near Gas Godown, PS Bhaktinagar Dist Jalpaiguri (4) Firoj Hussain-26yrs s/o Kamrul Hussain of Maharaj colony, near sony Mandir ward no-4, PS Siliguri Dist Darjeeling and 3/4 others also arrange for its investigation.
