I, Sri Manik Das, (45), Assistant Engineer (Electrical) & Station Manager, NJP Gate Bazar C.C.C, WBSEDCL, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Badal Chowhan to the effect that, on 04.07.2025 in course of inspection, myself along with Shri Bhaben Roy, S/O: Late N.C Roy, SO of Darjeeling Regional office, WBSEDCL, Sukanta Talukder, Sr. Office Executive, S/O- Late Santosh Talukder, Shri Subhankar Neogi, Linesman, S/O: Late Swapan Kumar Neogi of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Shri Badal Chowhan, S/O: Late Hiralal Chowhan of Mical Modhusudhan Colony, P.S. NJP, Dist: Jalpaiguri at 13.10 Hrs. Prior entry to the premises, a notice was issued in the name of Shri Badal Chowhan for inspection of the said premises which was received by Badal Chowhan, the consumer.. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the consumer of the said premises we conducted inspection.

During inspection it was found that, there has one domestic connection vide consumer id: 400356398 in the name of Badal Chowhan in the premises from which he has made unauthorized extension of line to other the premises, where there have a disconnected service line vide consumer number 412246257 in the name of Sabitri Chowhan having outstanding due amount Rs. 14,864.07. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line was disconnected & meter was dismantled. During inspection load of electricity consumption as observed in the same premises was 1.29 KVA. On being asked, Shri Badal Chowhan admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Shri Badal Chowhan, S/O: Late Hiralal Chowhan of Mical Modhusudhan Colony, P.S. NJP, Dist: Jalpaiguri has committed offence for which he is liable for prosecution U/S 135(1) (e) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 04.07.2025 from 13.40 hrs. to 14.05 hrs at the same premises in presence of the consumer.

Seizure: -

1. One Single phase meter, vide meter number GE1088203, Genus make, 5-30 Amp, 230 Volt.

Copies of seizure list and inspection report were delivered to Shri Badal Chowhan.

Therefore, I request you to kindly treat this complaint as F.I.R. against aforesaid Shri Badal Chowhan and arrange for it's investigation.

Original inspection report, seizure list, notice, one sealed packet containing seized article affixed with original label and another seal packed C.D containing video recording are being handed over to you for necessary action.
