Sir,

I, SI Tanmay Kundu of New Jalpaiguri Police Station in producing herewith one arrested accused person namely Juned Alam (24) s/o Md Yunush of Dewga, Kanki PS Chakuliya Dist Uttar Dinajpur with one seized vehicle displaying registration no WB 63-9498 and do hereby lodge this written complaint against him after producing him under arrest.

In this regard I beg to complain that today on 06.07.25 at about 0015 hrs. received a secret information that one vehicle was coming from Jalpaiguri side towards siiguri with a false number plate. Accordingly, I diarized the information in General diary vide NJP PS GDE No 277 dated 06.07.25 and informed the fact to you. As per your kind order and direction myself along with ASI Manoj Majumdar C/1462 Sajan Tamang VP 13 Jamirul Islam all of NJP PS left for Tinbatti more under PS- NJP, to verify the veracity of the information. Under such urgent circumstances any search warrant or authorization for search could not be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. At 00.40 hrs we arrived at Tinbatti more, in front of Bus stand under NJP PS. After long time and as indicated by the source we saw that one vehicle displaying no WB 63-9498 was coming from fulbari side towards Noukaghat. After seeing the police party the driver of the vehicle increase his speed and try to fled away from the sport but somehow we managed to stop the vehicle displaying no WB 63-9498. On interrogation, he disclosed his identity as noted above. On demand he failed to produce any document regarding the vehicle which was he drive. Then we try to matched the displaying registration no, engine no and chaise no but it seems to be tempered.


Then I interrogate the apprehended person and during enquiry he admitted that the displaying number plate is false and the original number plate of the vehicle is different. Hence it is strong reason to believe that the vehicle is a stolen property which was used to use in the crime on other purpose. Then I seized the vehicle displaying number plate WB 63-9498, The search, seizure were made in between 02:45 to 03:05 hrs and subsequently I arrested them by preparing memo of arrest and informing him the ground of arrest.

Therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Juned Alam (24) s/o Md Yunush of Dewga, Kanki PS Chakuliya Dist Uttar Dinajpur and others under proper section of law and its investigation may kindly be arranged.
