Subject: Complaint against my Daughter-in-Law for Harassment, Illegal Confinement, Mental Cruelty and Threats

Respected Sir/Madam,

- I, Kamala Agarwal, W/o Sri Daulat Ram Agarwal, aged about 74 years, residing at Kabithirtha Sarani, Lake Town, Siliguri, P.O. Lake Town, P.S. NJP, District Jalpaiguri would like to lodge a complaint stating as below:
- 1. That I am a senior citizen currently residing with my husband namely Daulat Ram Agarwal, aged about 77 years who is also a senior citizen.
- 2. That on 11.12.2019, our son namely Vinay Agarwal got married to one Deepa Kumari Prasad at Panchayat Bhawan, Church Road, Siliguri.
- 3. That initially my daughter-in-law exhibited considerate behavior and was filial but since the year 2022, she has been treating me and my husband in an inhuman and cruel manner and also has been avoiding fulfilling her basic responsibilities.
- 4. That my daughter-in-law persistently refused to contribute to household responsibilities, leaving me no alternative but to do everything on my own and has also deliberately deprived me and my husband of food and basic necessities, thereby subjecting us to humiliation and suffering.
- 5. That in the year 2022, after being treated in such cruel manner, me and my husband decided to shift in the empty room on the 2nd floor of the building inorder to gain some mental peace and tranquility.
- 6. That even after we shifted to the 2nd floor, the kitchen still remains the same and we being old usually rely on our daughter-in-law for some food but she not only denied food to us but even refused food to her own husband due to which I despite being old cooked food to feed ourselves.
- 7. That my daughter-in-law abused her own child i.e. my granddaughter and also frequently neglected her and avoided fulfilling her motherly duties.
- 8. That since last 2-3 months, my daughter-in-law frequently locks the main gate of the house, deliberately leaving me and sometimes me and my husband confined in the premises and taking the keys with her, thereby illegally confining me to the house without access to food or essential needs, lately on 10/04/2025 she has confined us for more than two hours.
- 9. That my daughter-in-law is neglecting her marital obligations towards my son as well and frequently creates a hostile and toxic environment in the house disrupting peace and family harmony.

- 10. That her demand for materialistic goods has increased and my son being a mere serviceman in a private firm is tormented by her regularly increasing demands leaving
- 11. That she has recently begun using abusive and offensive language towards me, and on several occasions, has threatened to lodge false and fabricated criminal complaints against me and my family members with malicious intent.
- 12. That whenever I bring these instances of inhumane and disrespectful behavior by my daughter-in-law to the attention of my son, he expresses his own distress and helplessness regarding the situation and is unable to intervene effectively which is leaving him frustrated and emotionally drained.
- 13. That on 07.07.2025, when my son requested me to get the breakfast ready early as he had to leave for his work urgently, I went to the kitchen to prepare him a breakfast as the stove was empty.
- 14. That as soon as she noticed I was in a hurry, she deliberately occupied both burners of the stove and continued cooking various things unnecessarily for the next 25 minutes, causing intentional delay.
- 15. That when I politely pleaded with my daughter-in-law to let me use one part of the stove, she blatantly refused and issued threats against me.
- 16. That fearing that my son would go to work empty-stomach, I repeatedly requested her, but she suddenly became extremely enraged, began shouting abusive language, and in a fit of uncontrollable anger, physically assaulted both me and my son, leaving us deeply shaken and emotionally distressed.
- 17. That thereafter, she left the house in anger and threatened to file a false complaint against us and to bring members of the "Mahila Samiti" to falsely implicate me and my family.
- 18. That due to her continued ill-treatment and threats, I am living in constant fear for my safety and well-being. Her behavior is causing severe mental trauma to both me and my husband.

I am a senior citizen and such treatment is deeply disturbing and I request you to kindly take appropriate legal action against her to ensure my safety, peace, and dignity.
