Sir,

I, Priti Chhetri, Wife of Sajit Kumar Chhetri, presently residing at C/O- Ranjit Kumar Prasad, Champasari More, near SBI ATM, P.S.- Pradhan Nagar, District-Darjeeling, would like to inform you that I was married to Sajit Kumar Chhetri, Son of Late Hem Kumar Chhetri, resident of Goth Gaon, Chamong Tea Garden, Pokharibong Bong Bazar, P.S.- Sukhia Pokhri, District- Darjeeling on 04/03/2001 as per Hindu rites and customs at Rangbhang busty, Lower Tarshing Dara, Darjeeling.

That after marriage I noticed that my husband is a habitual drunker. He was addicted to drinking and gambling. Not only this I noticed that my husband is a womanizer and he had several illicit affairs.

When I rented a house at Panchnai Residency, Ambardhura, Sahid Path, Methi Bari, Salbari, Siliguri for my daughter education. That when during his leave my husband come to stay with me, he used abusive language against me. He used to beat me in front of his daughter and even assaulted his daughter. One day he became so furious that he tied me and my daughter with gas cylinder and threatened to burn us alive and also asked me to marry again so that he could marry again. That because of his conduct I and my daughter used to live under threat and whenever he used to come home, sometimes out of fear I and my daughter stayed at our relative house. He threatened over phone that he will kill us with khukri. That when my parents tried to make him understand to rectify his behaviour, he did not listen and acted as per his whims and misbehave with me for no reason. That thinking about well being of my daughter and social status, I did not lodge any complain before any authority. That on 15th January, 2025 my mother called me up and informed me that my husband has married again and he is living with a lady from Nepal at Goth Gaon, Chamong Tea Garden, Pokharibong Bong Bazar, P.S.- Sukhia Pokhri, District- Darjeeling.

I or my daughter asked him to come and stay with us, he shouts at us and on February, 2025 he blocked me and my daughter over phone. Subsequently, I called up the relative of my husband and they also confirmed that my husband has married again. He even sent messages to my daughter on 27th February, 2025 stating not to call him again or chat with him and told her that he will not pay any maintenance.

That on 14th April, 2025 my daughter sent a mail to her father and my husband confirmed my daughter via email that he has married again but I did not lodge any complaint immediately against my husband as I and my daughter were financially dependent on him and he was sending maintenance amount. But from May, 2025 he stopped sending any money for our maintenance.

When I called him for monthly maintenance which he stop to send, he threatened me of dire consequences if I call him again and asked me not to disturb him further as he is living with a lady whom he has married. That I asked him to return my gold jwelleries (stridhan) which my parents have gifted me and which I entrusted to him immediately after my marriage on being asked by him, as he told me that he will keep them properly. But he refused to return my gold jewellries and threatened me not to call him again. He also refused to give our ration card.

That I therefore request you to look into the matter and take necessary action against my husband who is presently residing at Goth Gaon, Chamong, Pokhri Bong Bazar, P.S.- Sukhia Pokhri, District- Darjeeling with one lady and his phone no is 9882240264/9882730386.
