Respected Sir,

I am reporting that I have received threat again and again from Guddi Prasad wife of Tripurari Prasad who is also staying with us.

Guddi Prasad deliberately injured me by closing forcefully to my room door on 7th July 2025. I got injured on my left leg, my mom also saw all this incident as she is fighting. I concerned that for my safety and immediate request and guidance on the next step.

I request to provide security for me as it is very urgent and risky to stay there. I am already going through medical treatment. Guddi threat me by telling that I will spoil your life like as hell. I will also injure you the way I have done to your mom, Lakshminar Devi. She is also telling Siliguri police can't do anything to me as before also I have done the mistakes and injuries. In past she had hit my mom severely. I don't want my mom to struggle so I do take care of my mom. Tripurari Prasad stole Stole 50,000 from my mom's SBK account and also from Gramin Bank account. My mom wants back her money back as she is suffering a lot after losing money. Nobody asking her for food also.

Tripurari took my mom's Gramin Bank passbook and cheque book while she wants back. Tripurari doing transactions without my mom's permission.

On 7th July Guddi has injured me badly in front of my mom. Request you to please Register FIR against Guddi Urgently.
