I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Ram Chandra Adhikary, S/O- Late Narendranath Adhikary, Address: Niranjan Nagar (near Bat-Tala), Ward- 36, Siliguri, P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006, has committed Theft of Electricity under section: 135(i) (e) of the Electricity Act, 2003, read with further amendments for using the connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic) (Ref. Consumer ID: 412131598) as stated here under.

On 09.07.2025 at about 12:30 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Bijay Lakra, DE (E), 2. Mr. Bhaben Roy, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 3. Mr. Arnab Ray, J.E. (E) (Grade-II), 4. Mr. Biplab Sarkar, Sr.OE & 5. Mr. Mangru Baraik, Hg.TSH, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mr. Ram Chandra Adhikary, S/O- Late Narendranath Adhikary, Address: Niranjan Nagar (near Bat-Tala), Ward-36, Siliguri, P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 412131598), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection, the aforesaid person was detected consuming Electricity dishonestly in unauthorized manner by Using the Domestic Service Connection against Consumer ID: 412131598 & Meter No.: L1012129 for Domestic as well as Commercial purpose for a furniture manufacturing shop situated in the front portion of his aforementioned land property viz. using the electric connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic). Moreover, during inspection, the last reading was found 25208 KWh dated: 09.07.2025 (Inspected Load: 4.0 KW). Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected the Service Connection as per norms and seized one number single phase Energy Meter with P.P. Box having Device SI No.: L1012129, Make: Landis-Gyr, Rating: 240V, 5-30A, 50Hz, 3200 imp/KWh (L.R.: 25208 KWh) connected with some portion of Incoming & Outgoing wires which has been used for consuming electricity dishonestly in unauthorized manner viz. Pilferage of Electricity as described above under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & Son & other representatives of the Accused Person. The inspection team members left the aforesaid premises at 13:10 hours on the same day after observing all formalities.

So the accused person, Mr. Ram Chandra Adhikary, S/O- Late Narendranath Adhikary, Address: Niranjan Nagar (near Bat-Tala), Ward- 36, Siliguri, P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006, has committed Pilferage of Electricity under section: 135(i) (e) of the Electricity Act, 2003, read with further amendments for using the connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic) (Ref. Consumer ID: 412131598).

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
