Sir,

In producing herewith one arrested accused person namely Subham Sahani @ Godu (20yrs) S/O- Shambhu Sahani of Bhabasindhu colony, near Radio center, Ward No-42, PS - Bhaktinagar Dist - Jalpaiguri along with the following seized articles under seizure as per seizure list:

- (i) 21 (Twenty one) Bottles of R-Kuff Cough Syrup each bottle containing 100 ML having Composition, Chlorpheniramine Maleate IP 04mg, Codeine phosphate IP 10 mg (Total weight 21pcs X100 ML=2100 ML = 2.1 Ltrs)
- (ii) One blue colour back pack "Quechua" written in outside of the bag.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 09.07.25 at about 19.10hrs, received a reliable source input that male person was standing at P.C Mittal bus stand, ward no-43 under Bhaktinagar PS with huge quantity of illegal cough syrup for delivering the same to his designed customers at Siliguri area for his wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 545 dated 09.07.25 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 19.20hrs myself along with SI Yuel Lepcha, ASI Dipak Karmakar, ASI Dhurbo Mishra, ASI Khagen Barman, Const/374 Debraj Biswas, all are Bhaktinagar PS with investigation kit left for P.C.Mittal bus stand, ward no-43 by govt vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE no. 546 dated 09.07.25 and M.C.C No- 3471/2025 Dated 09.07.25.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 19.30hrs we reached at P.C Mittal bus stand, ward no-43 PS Bhaktinagar and meanwhile called two independent witnesses namely; (1) Adip Pradhan-42yrs s/o Tek Bahadur Pradhan of Manpuri busty, Gandhinagar, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Chirag Rai-26yrs s/o Lt Nayan Rai of Manpuri busty, Gandhinagar, ward no-43, PS Bhaktinagar Dist Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. After sometime waiting there and being accompanied by source and the witnesses our whole police party detained one male person at P.C Mittal bus stand, ward no-43 PS Bhaktinagar. We disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he disclose his name and address as noted above and also found that one big size nylon bag in his hand. On being asked he admitted that he had illegally possessed Cough syrup in his possession for selling the same to his designed customers as per requirement for his wrongful gain.

I then gave an option in writing whether will willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given in written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station to come to P.C Mittal bus stand, ward no-43 PS Bhaktinagar requested him to ~~presence~~ during search and seizure of the Cough syrup. Accordingly at 21.20 hrs Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his

Supervision in presence of witnesses the process of search of the detained person for conducted following all formalities and recovered the above noted articles from the possession of above noted accused person. Subsequently, being demanded in presence of Shri Amit Adhikary, Inspector In-Charge, Gazetted Police Officer the detained person failed to produce any valid document in support of possessing of the cough syrup.

Thereafter, I recovered one back pack containing with total 21 (Twenty one) bottles of R-Kuff Cough Syrup each bottle containing 100 ML having Composition, Chlorpheniramine Maleate IP 04mg, Codeine phosphate IP 10 mg (Total weight 21pcs X100 ML=2100ML = 2.1 Ltrs) which was kept inside in above noted bag. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labelled and sealed all the articles under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and witnesses and accused person. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between 21.40hrs to 22.30 hrs.

Being further asked, the apprehend person namely Subham Sahani @ Godu (20yrs) S/O- Shambhu Sahani of Bhabasindhu colony, near Radio center, Ward No-42, PS - Bhaktinagar Dist - Jalpaiguri admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that he procured the cough syrup clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he had been dealing in such business of procuring and selling of cough syrup illegally for last few months.

Then, I arrested the above noted accused person namely Subham Sahani @ Godu (20yrs) S/O- Shambhu Sahani of Bhabasindhu colony, near Radio center, Ward No-42, PS - Bhaktinagar Dist - Jalpaiguri after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Subham Sahani @ Godu (20yrs) S/O- Shambhu Sahani of Bhabasindhu colony, near Radio center, Ward No-42, PS - Bhaktinagar Dist - Jalpaiguri and arrange for its investigation.
