With due respect it is to inform you that I, Baldurya Biswas, wants to lodge a complaint about motorcycle accident took place at Lexican more on 30/06/2025 at approximately 01:05 pm. On that day I was travelling towards city centre from NBU with my friend Raju Sarkar by Motorcycle and it was being driven by me. At that above mentioned time I was moving forward as the traffic signal was open for us and then one motorcycle suddenly came from left side road with high speed having vehicle number WB74BM0046, collided with my bike. As a result my left hand specially fingers and left leg got injured. Huge bleeding was started from my hand and at that moment the traffic police officer Rupam Ghosh came and suggested to urgently go to hospital by stopping one toto, and also helped to keep my motorcycle beside the road. I was admitted to Neotia Getwel Hospital by my friend in Emergency section. After diagnose and X-Ray it was reported that deep cut in two fingers and one finger was broken. Since then I stay alone in my house with my mother aged 67 years. After this incident my physical condition is not well and facing trouble to move alone and at the same time my mother also falls ill. As I was being busy for my treatment purpose I am late to lodge complaint.

Therefore, I would like to request you that you would be kind enough to take necessary action against the bike driver as early as possible and make me obliged thereby.
