Sir,

With due respect I Sri Akhil Biswas @ Akhil-Chandra Biswas of Matri Mandir Apartment, Sreema Sarani, Babupara PO & P.S Siliguri, Dist: Darjeeling would like to draw your kind attention on the following affect that since 2012 the aforesaid two persons hatched up a deep rooted conspiracy to squeeze my hard earned money for their illegal gain for which they co jointly developed a good relation with me and earned my confidence by several means. During the lifetime of Nawal Kishore Soni, one day probably in the year of 2013-2014 the aforesaid Shibnath Ganguly and Prashun Dasgupta @ Chaki requested me to deliver Rs, 5,00,000/- to Nawal Kishore Soni because that amount was required by him badly at that time I gathered the said amount from different source and given in the hands of said Shibnath Ganguly in cash but thereafter Four lakhs was paid by Shibnath Ganguly to me out of Five lakhs but rest One Lakhs was not paid to me after repeated requests. In the year of 2016 said Shibnath Ganguly asking Rs Four lakhs from me for the club account (Baghajatin Athletic Club) for requirement of the club with the condition to repay the same very shortly, on good faith I had given the same but thereafter I several times asked him to repay my hard earned money but he told me that the club members were misappropriated the same but Rs. 1,90,000/- was paid to my son in Law for his urgent requirement and those amount he assured me to return on time but till now he is moving me like a shuttle cock. Thereafter one day aforesaid two persons along with one Kushal @ Bhaitu Da came to our chamber cum residence in respect of Twenty Bighas Land of Bhaitu Da alongwith all land papers of Gajoldoba of Bhaitu Da and some local people of the adjacent land raised some objections regarding the possession of the said land at that time being an advocate, I uprooted the entire tax of the said land and obtained certified copies and identified the land by a Government Surveyor incurring near about 90,000/- approx. as per word of them but presently I came to know the aforesaid land was sold out but my incurring amount alongwith professional fees cheated by them. The aforesaid persons always tried to insult me by several means. Today at about 2P.M. went to my friend's house adjacent to Baghajatin Athletic Club but in front of the gate of Friend's house said Shibnath Ganguly obstruct me and hurling unparliamentary languages by saying that "TUMI BHODRO LOK NOYE" in presence of my driver as a result I sustained severe mental pain and agony and presumed that my reputation will ruin in presence of my driver and passerby's. After several requests they did not pay any heed to it of returning my money alongside my reputation was also being hampered by them and they tried to digest my entire hard earned money which was given by me to them.



In view of above you're requested to look into the matter to recover my hard-earned money and also punish them for their acts and activities
