Birendra choudhury, started abusing us in filthy languages and when we protested he picked up brick and from the ground and hit it on the head of my said brother and bleeding started coming out from his head and he was immediately shifted to Dr. Mukherjee's Nursing Home, H.C. Road, and still under treatment there. in serious condition, since he has vomited 03 to 04 times after that.

It is pertinent to say that my grandfathers namely Lt. Gangaadhar choudhury had 02 (two) sons namely Birendra choudhury & Gajendra choudhury, and our dwelling house is still in the name of my grandfather namely, Sub. Manorama choudhury (?) w/o Lt. Gangaadhar choudhury, but my said uncle want to evict us from our ancestral house.

The above noted alleged persons are very dispute & dangerous in nature, and he has threatened us for dire consequences, if we will not leave our said common property.

So, please take necessary action against them.
