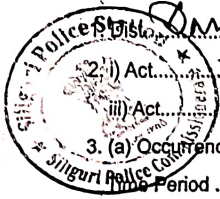

Ganesh Road, Santoshi Ngram, Ward No. 5, P.S.-Siliguri)
reached near Santoshi Mandir, Santoshi Ngram, at
that time, nearly 05 (five) persons noted above,

& 02 (two) unknown associates, restrained my vehicle
and started abusing me in filthy languages and
when I protested, they attacked on me with iron
