Subject: Request for FIR Against Mr. Rajkumar Thapa/Chhetri for Mental Abuse, Fraud, Bigamy, and Threat to Life

Respected Sir/Madam,

I, Heena Pradhan, resident of Middle Palash, Debidanga, Champasari, under P.S. Pradhan Nagar, District Darjeeling, am writing this application to formally lodge a complaint against my husband, Mr. Rajkumar Thapa/Chhetri, a resident of Village Panchapada, Jharsuguda, Odisha, currently serving as a Government employee in B.S.A.P-1, Bihar Police.

We got married on 11th November 2023. However, after our marriage, I came to know that he was already married and has a son from that marriage — information that he deliberately concealed from me.

Since our marriage, I have been subjected to severe mental abuse, emotional trauma, and financial exploitation. He left me burdened with debts and has completely abandoned me. I was also forced to go through an abortion due to the stress and instability caused by his behavior. He has taken no responsibility for my physical, emotional, or financial well-being.

In August 2024, I discovered that he is involved in an extra-marital affair with his ex-girlfriend, Ms. Pragya Chhetri. When he learned that I intended to report his actions to the authorities, he began threatening me to my life.

I am currently living in fear and have been mentally devastated by his conduct. Therefore, I respectfully request you to register an FIR against Mr. Rajkumar Thapa/Chhetri under the relevant sections of the IPC for cheating, mental harassment, criminal intimidation, bigamy, and other applicable offenses. I kindly urge you to initiate immediate and appropriate legal action against him.

I am willing to provide any further details, documents, or evidence required to support my complaint.
