Raj along with 400 to 500 persons to the effect that on 09.07.2025 I was detailed at Bagra Cote to maintain law & order duty in C/W STRIKE called on by CPI(M) Vide MCC No. 2140 Date 09.07.2025. till 12.30 hrs the situation was normal so far, at around 12.45 hrs I received an information that a group of people may appear at Bagra Cote old rail gate area over a previous issue where two groups of young's organised a cricket match at Bagra Cote under SMC Ward No. 20 area and became engaged in a hot altercation. It also learnt that the group of the persons may attack other group of people resides opposite side of the rail gate with an intention to cause harm both bodily and they may cause damage to their property. After receiving the information I informed the tiff of to you as well as other superior officers and rushed to the area to avoid any kind of adverse situation which refers to Siliguri PS. GDE No. 414 Date. 09.07.2025.

At around 13.10 hrs I found a group of 250 to 300 unruly mob armed with sword, lathi, bamboo, iron rod, hockey sticks coming towards Bagra Cote old rail gate by raising communal slogans by indicating the opposite groups, accordingly I intervene and tried to stop them and to control the situation also stated them that they assembled at the spot illegally but in vain, in presence of me they started pleating stones towards the opposite communities and the situation got worse, at the same time a group of 150 to 200 persons assembled opposite side of the rail gate also carrying lathi, bamboo, iron rod, hockey sticks who belongs to the other community. Immediate after that mob proceeds towards Tikiya Para Ward No. 28 by crossing the rail gate and both the parties were going to engage in frontal clash and using communal related hate speech towards each other. Immediate after that superior officers whom I informed earlier along with force appeared at the spot and intervene, as a result both

the groups of mob were forced to move to opposite sides of the rail way track. When the Police team trying to take control over the situation then suddenly the mob of both side became aggravated and without any provocation started pelted stone towards the Police. As a result Officers and force including lady force sustained bodily injury, in between this a member of the mob suddenly hit the constable who was carrying the Gas Gun with a iron rod, to save himself when the constable moved aside then the rod hit the gas gun as a result the gas gun got damaged. Which clearly indicates that the mob had an intention to injure Police team, also the mob restrained Police on their lawful duty.

Seeing the situation going out of control Police team started using force to disperse the unruly mob of the both side finding no other option two tear gas shells have been fired under the direction of superiors towards the unruly mob. After that finding no other options I able to apprehend the aforesaid persons and arrest them accordingly. Seeing the Police action and by using force we finally able to took control over the situation and the unruly mob dispersed from the spot and Police took control over the situation at around 15.25 hrs. After that we started Patrolling over the area and found due to the subversive act of the mob the law and order situation over the area had deteriorated and the unruly mob damaged the property of the peaceful public in general and some of the general public also sustained injury.

Over this facts and circumstances I therefore pray before you that took custody of the arrested accused persons namely 1. Jiaul Seikh (40) S/O. Lt. Gumani Seikh of Vill. Chalpara, PO. Jayanpur, Dist. Darjeeling and please start a specific case against this said arrested persons and against Bikramaditya Mandal of Ward No 4, Binay Barman of Ward No 4, Bikram Chetri, Prashanta Sarkar, Rakesh Agarwal, Kishan Agarwal of Khalpara, Bikash Gupta of S.P.
