Sir,
With Due Respect I Sarwila Begam D/o - Nijam Ali resident of Khalpara (Red Light area) would like to inform you that my daughter Moyina Khan works as a sex worker, under Mina Begam w/o - L.T. Munna Khan of some area since last (4) four years, since last (2) two years Mina Begam started discontinuing the payment which my daughter earned for which the amount credited to Rs- 80,000/- asking her to give me at least some money to celebrate I asked her to give me at least some money to celebrate Moharram supposed to be next day on 6/3/2025, she called me at her home, to give me the money on 5/3/2025 around 2 AM, I was just reached her gate her son Sunny Khan along with two unknown boys came and started abusing me by derogatory language and slapped me 4-5 times and caught me by hair and dragged me to his room closed the door and started beating me through out chest, forehead, head and almost whole my body by wearing a Iron punch in his hand, which swollen and dark marks occurred, then after he tried to kill me throttling my neck by my scarf however I managed to save myself and fled at my home soon after reaching home my chest started paining badly and bleeding by mouth, my daughter along with local people took me to Siliguri District Hospital where Doctor suggested emergency admission followed by C.T. Scan, Chest X ray and other tests, also I would like to bring this to your notice that Sunny Khan threatens us if we leave their home and work elsewhere he will kill us by calling sugar killers from Bihar which he has extreme links with, he also keeps iron punch and lethal weapons with him always, Our life has big threat because of Sunny Khan, therefore I request your kind attention towards necessary action and protection of our life also I would like to describe that I am a H.I.V. Patient.
