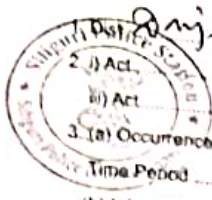

Sub: Disturbance and Misconduct by Co Legal Heirs

Respected Sir,
I, Anil Kumar Agarwal son of Late Mangtaram Agarwal, resident of Agrasen Road,
H/No.: 122/498/518, Khalpara, Ward No.9, SMC, Siliguri:734005, want to bring to
your notice that Amit Agarwal and Sumit Garg, both son of Late Nagendra Kumar
Agarwal and Vandana Agarwal, wife of Amit Agarwal resides along with their other
family members at the 1st floor of the same premises by virtue of being legal heirs in
the said property. Since few months, all mentioned above are restraining me, my
other family members and staffs to use the staircase which is for common uses by all
in the said undivided premises. Whenever we try to communicate in an amicable
manner for such disturbance, they react very aggressively and often not only uses
filthy language and abuses us but also make physical assault. They also threaten us to
prepare for much more horrible consequences and ask us to leave the premises.
Recent such incidence took place on 1st July'2025 at the second floor of the premises
when I, along with my staff was bringing some catering goods to downstairs. Several
efforts have been to make them understand that the staircase is for common use
and also to resolve the issue, if any, but all has failed.
My mother is 87 years old and my elder brother is a heart patient and along with
other family member we all live together. Under such precarious situation, I had no
other resort to report to your good self.
I hereby request you to kindly look into the matter and take necessary action with
immediate effect.
