With due respect I Sonu Kumar Yadav, S/o Etawar Chand Ray, of Vill. & Post- Marhaura, Dist.-Saran, Bihar, do hereby lodged this complaint with the information that on dt. 07/07/2025 at about 05:00 AM, while my younger brother Guddu Kumar Yadav was moving towards Siliguri from Bihar in a Pick UP Van bearing no. WB73E7519 along with one Sunil Kumar, S/o Ganesh Ray resident of Karanpura, Marhaura, Saran, Bihar and one Md. Abdul (driver), S/o unknown, resident of Gandhi Nagar, PS- Bhaktinagar, Siliguri while they reached near Sanyasikata under PS Bagdogra one truck bearing no. WB59C3298 which was coming from the opposite side, in a rash and negligent manner dashed the Pick UP Van resulted to which the driver Md Abdul and my brother Guddu Kumar Yadav and Sunil Kumar sustained grievous injuries on their person they were taken to NBMC & Hospital, Siliguri, where attending Dr. declare my brother as brought dead and Md. Abdul and Sunil Kumar were admitted there for medical care.

My brother's Post mortem was done asper Matigara PS UD case no. 753/25, dt. 07/07/2025 at NBMC & Hospital, Siliguri.

Hence today I am submitting my written complaint to you with a request to take legal action against the driver of the offending truck bearing No. WB59C3298.
