In producing herewith the accused person named Bhola Das, aged 52 yrs, s/o- Late Bhuban Chandra Das, resident of Trailakya Nagar, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 3738 2711 4428) under custody along with following seized articles under proper seizure list:

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Bhola Das, aged 52 yrs, s/o- Late Bhuban Chandra Das, resident of Trailakya Nagar, PS- Bagdogra, Dist- Darjeeling to the effect that on 06.07.2025 at around 21:25 hrs in course of performing PC Mobile van duty vide Bagdogra PS GDE No. 274 dated 06.07.2025 I received reliable source information that a huge quantity of liquor is stored at the grocery shop styled as "Shrestha Enterprise" of one suspect named Bhola Das located at Bagdogra Bihar more and the same has been selling illegally from that house for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with SI Debabrata Kundu, SI Binup Mahato, ASI Amit Lama, C/1509 Sourav Roy Sarkar, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Bagdogra Bihar more under Bagdogra PS, SPC to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 21:35 hrs we reached at Bagdogra Bihar more and being indication & identification by source we held raid at the shop styled as "Shrestha Enterprise" of the suspect Bhola Das and managed to apprehend the suspect with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Bhola Das, aged 52 yrs, s/o- Late Bhuban Chandra Das, resident of Trailakya Nagar, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 3738 2711 4428) who introduced himself as the owner of that shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. None agreed to be present there as independent witness. Then, we searched the shop of the suspect Bhola Das in presence of the Police personnel. On search, the above noted liquor was recovered from that shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he had been stocking, possessing & selling liquor illegally from his shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Bhola Das (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 21:36 hrs and 22:00 hrs on 06.07.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person Bhola Das, aged 52 yrs, s/o- Late Bhuban Chandra Das, resident of Trailakya Nagar, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 3738 2711 4428) and arrange for its investigation.
