Sir

With due respect and humble submission I ASI Aibul Islam of Matigara P.S. beg to submit that on 11/07/2025 myself along with force were detailed to perform Mobile Patrol duty, vide C.C. No. 2159/25, Dated 11/07/2025 and GDE No. 530, Dated 11/07/2025. During my said mobile van duty, I received a source information that one Truck is loading river bed material at Balasan River Ghat, Parimalnagar, P.S. Matigara, having no document/Royalty in respect of said load. Accordingly I informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to Balasan River Ghat, Parimal Nagar, under Matigara P.S. Seeing the police party, driver/owner of the vehicle fled away. We could detain one Truck bearing No. WB73C4980 (SML), blue coloured loaded with river bed materials. It may be presumed that the Driver/Owner of said Truck procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from Balasan Ghat, Parimal Nagar, for their wrongful gain and trying to proceed to deliver the same to their designated customer. I searched for the driver/owner of said vehicle but in vain. Nobody came forward to claim the vehicle. Finding no other alternatives, I seized the Truck bearing Regn No. WB73C4980 (SML), loaded with river bed materials, preparing proper Seizure List also brought the truck to PS. Search and Seizure was made in between 09:40 hrs to 09:51 hrs on 11/07/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver/owner of Truck bearing Regn No. WB73C4980, loaded with river bed materials, and arrange for it's investigation.
