Sub: F.I.R. against Shri Raju Das, S/O: Shri Robi Das, vill: East Dhantala (near Helipad Ground Battala), P.O: Satelight Township, P.S. NJP, Dist: Jalpaiguri for committing offence U/S 135/1(a) of The Electricity Act' 2003 amended in 2007.

Sir,

I, Sri Manik Das, (45), A.E. & Station Manager of NJP Gate Bazar CCC, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Raju Das to the effect that, on 11.07.2025 in course of inspection, myself along with Bijoy Lakra, S/O: Bernard Lakra, Divisional Engineer (Elect.), Shri Bhaben Roy, S/O: Late N.C Roy, SO, both of Darjeeling Regional office, WBSEDCL, Shri Subhankar Neogi, Linesman, S/O: Late Swapan Kumar Neogi, Shri Ashes Gurung, S/O: Shri Bikash Ch. Gurung, both are of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the village East Dhantala (Near Videocon Helipad ground, Battala), PO: Satelight Township at time 12.30 Hrs, In course of checking of LTOH line we noticed an unauthorized hooking from LTOH line through PVC cable, which entre into the Shop of reportedly one Raju Das. Following that pvc cable we reached at commercial premises of Shri Raju Das for inspection of electrical appliance. Prior entry to the premises, a notice was issued in the name of Raju Das for inspection of the said premises at 12.58 Hrs which was received by him under his signature. I arrange to call witnesses from the vicinity. In presence of available witness of the said premises conducted inspection.

During inspection in presence of witnesses it was found that, Shri Raju Das was using electricity unauthorized by way of direct hooking through PVC cable from nearest LTOH line of the WBSEDCL, within the jurisdiction of NJP Gate Bazar CCC which was connected to load circuit. This illegal hooking through pvc cable made a loss of revenue to the WBSEDCL. Shri Raju Das was using electricity illegally to run electrical appliances at his commercial premises. We also detected that, there have an old service connection which was in deemed disconnected having OSD Rs. 24,992.76 in the same premises in the name of Dinesh Mondal, the seller of the shop property. On detection of theft, illegal line was disconnected and dismantled from the WBSEDCL line. During inspection load of electricity consumption as observed in the same premises was 0.255 KW. On being asked, Raju Das admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Shri Raju Das, S/O: Shri Robi Das, vill: East Dhantala (near Helipad Ground Battala), P.O: Satelight Township, P.S. NJP, Dist: Jalpaiguri has committed offence for which he is liable for prosecution U/S 135/1(a) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 11.07.2025 from 13.05 hrs. to 13.25 hrs at the same premises in presence of available witnesses with its label, this was used for committing aforesaid offence.

Seizure: -

1. One PVC cable 2 core, color black having length-15 feet (portion taken), with hooking arrangement in its one end.

Copies of seizure list and inspection report were delivered to Shri Raju Das.

Therefore, I request you to kindly treat this complaint as F.I.R. against aforesaid Shri Raju Das and arrange for it's investigation.

Original inspection report, seizure list, copy of label and notice and one sealed packet containing seized article affixed with original label are being handed over to you for necessary action.
