Sir,

I, SI Dipankar Chakraborty of New Jalpaiguri PS, Siliguri Police Commissionerate , do hereby lodge written complaint, on producing one arrested accused person namely Krishno Mohan Roy (59/M) s/o Lt Roshik Roy of Madani Bazar, PS New Jalpaiguri, Dist.- Jalpaiguri under arrest along with following seized articles;

1. Fifteen (15) sealed Bottles of Himalayan GOLD country spirit, 60 Up, each bottle containing 600 ml and marked as Ex-"A".

I am submitting a written complaint against the above noted accused person to the effect that today 11.07.25 at 18.45 hrs. I received source information that one person was carrying and selling ID Liquor illegally at Madani Bazar under NJP PS in his shop to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with, NVF-089 Shyamal Roy, CV-440 Jibon Roy, all of NJP PS, SPC left for Madani Bazar to verify the veracity of information vide NJP PS GDE No.593 Dated- 11.07.25. On arrival at the spot on 11.07.25 at 19-05 hrs it was found that one person mentioned above was selling liquor illegally at his shop situated at Madani Bazar to his designated customers to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally to his designated customers without any license. Thereafter in presence of witnesses I recovered 1) Fifteen (15) sealed Bottles of Himalayan GOLD country spirit, 60 Up, each bottle containing 600 ml from his possession and seized the same as per proper seizure List and labeled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 11.07.25 in between 19-15 hrs to 19-45 hrs. (seizure Total approx 9 Liters).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Krishno Mohan Roy (59/M) s/o Lt Roshik Roy of Madani Bazar, PS New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
