11/07/25 and at around 11 AM Santosh Paswan along  
with 3 of his associates came to my office and  
started creating nuisance. He started shouting  
and disturbing the office. Later he suddenly  
shut all the lights and fan and tried to  
kidnap me for taking to NIP. He had come  
in a THAR Vehicle registration No: WB73L3777  
which is still standing in front of my office.  
His associates physically tried to pick me from  
my office chair. Further he had taken one of  
my vehicles bearing Registration No: WB73E4548  
for temporary 3/4 days some days back.  
Till date in spite of my repeated reminders  
he has not returned my vehicle. I have good  
reasons to believe that his associates were  
carrying some arms with them. CCTV footage  
of today's whole day is available if required  
can be produced.
