Respected Sir,

In producing herewith 02 tractor vehicles bearing Registration No- WB 71B 1448 and WB 73 F 8318 both loaded with River Bed materials (Sand) seized u/s 106 BNSS under proper seizure list.

I beg to report that, I SI Satish Ruchal of Bhakti Nagar Police station under Siliguri Police Commissionerate lodge a written complaint against the above noted vehicles to the effect that on 12.07.2025 at around 00.10 hrs while performing night Mobile van duty vide MCC No. 3396/2025, dated 11.07.2025 along with C/ 843 Suman Basfore & C/1432 Arup Chandra Biswas noticed that above mentioned 02 tractors were heading towards Salugara side via demdema busty, visibly loaded with River Bed Material suspected to be extracted illegally from Toribari Mahananda River bed under Bhaktinagar PS. On chasing the vehicles, the drivers and their assistants fled from the spot, abandoning the tractors on the roadside to evade police arrest. On checking the tractors I found both were loaded with river bedded materials (sand).

Accordingly, I shared the information with I/C Bhaktinagar P.S, SPC over telephone and as per his kind verbal direction, I seized the above noted tractor vehicles along with loaded river bedded materials (sand) u/s 106 BNSS under proper seizure list in presence of local witnesses. The whole process of search, seizure took place in between 00.40 to 00.55 hrs with proper audio & Videography.

During an preliminary enquiry it was revealed that none of the local could identify the owners and the drivers of the seized tractors. However they confirmed that the tractors had procured the sand illegally from the Toribari Mahananda River bed and were transporting it towards Salugara side for wrongful gain without any valid documentation. Both the seized tractor vehicles were brought to Bhakti Nagar PS.

Under the circumstances, I pray before you that kindly initiate a specific case against the drivers and owners of vehicles No. WB 71B 1448 and WB 73 F 8318 along with others persons involved under proper section of law and cause its investigation.
