Khatian 673 and 681 situated within Mouza-Abhiram, J.L. No. 67, Post Office and Police Station Bagdogra, District Darjeeling, Pin: 734014 within the limits of Hetmuri Gram Panchayat within specific demarcation by virtue of 2 (two) registered Deed of Sale being Instrument Number 040305645 for the year of 2024, Registered in Book No. I Volume Number 0403-2024, Pages from 117868 to 117880 and Instrument Number 040305646 registered in Book No.I, Volume No. 0403-2024, Pages from 117855 to 117867 for the year of 2024 respectively registered before the then A.D.S.R. Bagdogra. That Savita Kandulna Ekka and 9(Nine) others alongwith their men and

agents have been disturbing our peaceful possession in respect of the aforementioned land we were constrained to initiate a civil suit for declaration, permanent injunction and other consequential reliefs in respect of the aforementioned land before the Ld. Civil Judge(Junior) Division, At Siliguri alongwith an application Under Order 39 Rule 1 and 2 Read with Section 151 of C.P.C and the said suit is registered as Title Suit No. 89 of 2025. Court is/was pleased to pass an order that the defendant is restrained from creating any sort of interference, obstruction and annoyance in quiet and peaceful use, occupation, and enjoyment and possession of the Plaintiff in and over the suit property till 18.07.2024.(The Photostat True copy of Plaint, injunction application and information slip of the order is enclosed herewith for your perusal). Under the above circumstances I would request you to investigate the matter and initiate appropriate legal action for physically assaulting us and destroying and dismantling our residential house structure and theft away of valuable belongings including roofing sheets against Savita Kandulna Ekka and 9(Nine) others as mentioned in the plaint and against1.Surendar Tirkey, Son of Pusha Tirkey resident of Bhuttabari, Post Office and Police Station Bagdogra, District Darjeeling, Pin: 734014, 2.Barun Das, Son of Late Arjun Das Resident of Masjid Para, Airport More, Bagdogra, Pin: 734014 3.Pramod Sharma, Son of Ramdev Sharma, Resident of Vivekanandapally (East) Bagdogra, Pin: 734014 and 4. Pappu Yadav, Son of Sita Ram Yadav, Resident of Harekrishnapally, Post office and Police Station Bagdogra, District Darjeeling Pin: 734014 and would take all necessary steps so that the sanctity of the order of the court is protected.
