That in the year 2018, Mr Pradip Shaibya, (PH - 9641696685) son of Santosh Shaibya and Sanjeeb Shabya, (PH- 9564302277) son of Late Sukan Singh Shaibya introduced me to one Rabin Darjee @ Rabin Bardewa, (PH-7797930512) son of Tek Bahadur Darjee, all are resident of Dhimal Jote, P.O new Rangia, P.S - Bagdogra, Dist- Darjeeling, PIN- 734013, claiming that he was the 318 (4) /3(5) rightful and legal owner of a plot of land measuring approximately 1.4 kathas, recorded in khatian No. 13, Plot No - RS- 225, LR - 225, J.L. NO. 83, Touzi No. 91, Mouza- Dhemal, situated at Dhimal Jote, Bagdogra, P.S - Bagdogra, Dist Darjeeling, in the state of West Bengal. That trusting their representation and relying on their assurance, I agreed to purchase a portion of the said land from Rabin Darjee @ Robin Bardewa.

That a sale agreement was executed and I paid a sum of Rs, 10,50,000 (Rupees Ten Lakhs Fifty Thousand only) to Rabin Darjee @ Rabin Bardewa, Pradip Shaibya and Sanjeeb Shaibya on following dates

That according to Sale agreement Rabin Darjee @ Rabin Bardewa registered a said land on my name on dated 05.09.2018 in the office of Additional District Sub Registrar, Siliguri, II at Bagdogra, Vide deed No. 5911/2018, but on dated 28.02.2020, when I started a fencing work on the said land one NIL KAMAL MANGAR, son of Dil Bahadur Mangar obstructed a fencing work stating that the said land belongs to him.
