we appeared for the interview to Mr. Purbottam
Singh claiming himself the HR of the company,
from Kolkata and after the interview, we were
provided with the appointment letter (offer letter).
He again consulted us with Mr. Sanjay,
claiming as the Cluster Manager of the
same company for document verification, and we
received a call from Kaushtik Dutta claiming
the administrative head, and asked money
for training purposes and mentioned as it is

in the company named, and it would be refunded with the salary. The money was paid by us just to get the job, and this money was paid in the account of ~~Piplu~~ Piplu's wife namely Mrs. 'Rimpi Das'. I would also want to mention that the payments were made through online and cash. After the payment was done from us he started to delay the process and when we used to ask about the process, he used to say will be done today, or tomorrow and by this he crosses the days. After this delay month to month it has crossed the patience of mine. I thought of talking to his family and firstly I informed his wife Mrs. Rimpi Das, and asked her about him and the process of the job. She didn't showed any interest and released it by saying will look into it. After such and long delay, I asked for my money from their family members, his mother, father, and his wife, they just assured to pay the amount, and they started to give date after date and failed to pay. After this last date given by them was failed again, I stated them that I will launch an FIR against Piplu Das, after listening this his family started to give threat to me that if I launch a case, I won't be getting a single penny. I'm between this Piplu was given me a cheque of amount, ~~Rs~~, which was bounced.

Hence, I have a video evidence and all the details ~~which~~ which was provide to me by Piplu and all are attached with the application.

So, I would request you to grant
this application and launch an FIR against
Mr. Lipu Das, and help me and the other
persons to get their money, which they and I
have paid to him.
