Subject: FIR regarding Theft at Our Workshop Premises

Sir,

I would like to report a theft incident that occurred at our workshop located at Kaysons KIA 2.5 Mile, Sevoke Road, Opposite Bhaktinagar Police Station, Siliguri-734008, West Bengal on 13.07.2025, during the morning and afternoon hours.

As per our internal investigation and review of CCTV footage, it has been clearly observed that two unknown persons entered our premises and carried out the theft. This incident took place around 8:48 AM to 9:02 AM and 3:00 PM to 4:00 PM respectively, as captured in the CCTV footage. The theft took place during the daytime, specifically in the morning and afternoon hours. The matter appears serious and raises concerns regarding the safety and security of our premises.

As per CCTV footage two unknown persons unlawfully entered the premises and committed theft of valuable items, which includes especially valuable tools, vehicle parts, batteries and valuable cables of heavy equipment (List attached). This incident has caused considerable disruption and financial loss to our operations and severely affected our Bodyshop business operations.

As per our discussion, we are hereby providing you with the relevant CCTV footage clips for both time frames (morning 8:50 AM and afternoon 3:00 PM) to assist in your investigation.

We kindly request you to register this as an FIR and initiate necessary action at the earliest to identify and apprehend the culprits. We assure full cooperation from our side and are ready to provide any further information or documents required.

We hope for your prompt and serious attention to this matter.
